- EZ up and First Aid Kit\*
- Tables/chairs
- BBQ/Smoker/Grill with wood/propane/pellets
- Chafing dish, Cooking/Serving utensils and trays
- Thermometers
- Fire Extinguisher (minimum rating 5 lbs., Type AB)
- Sanitation supplies (bucket, Clorox, wiping towels, food service gloves)
- Table cloths, booth decor

\* Required in accordance to California's Environmental Health Department

**Rules and Regulations**

1. Meat must be picked up at the time and location specified by event coordinator.
  - a. Contestants must bring a sanitized cooler with ice to pick up their meat.
  - b. Contestants who do not pick up their meat at specified time will forfeit their entry fee.
2. Contestants must check in at event no later than 7am.
3. Contestants must maintain their assigned space in an orderly manner that meets California’s Environmental Health Department.
4. All ribs and chicken must be cooked/smoked onsite; Chili participants may pre-make their chili.
  - a. All meat should be cooked to a safe temperature as recommended by the USDA
  - b. Chili must be held at a minimal hot holding temperature of 135°F.
5. Each team is assigned a 10x20 space and all contestant equipment must fit within assigned space.
6. Contestants are expected to maintain a professional and friendly demeanor and may not sell additional tastings or their own products during the event.
7. Contestants **must** collect 1 tasting ticket per item sampled. Samples consists of Qty 1- chicken wing, rib or 2oz serving of chili.
8. Voting will be done by the public by placing their votes in individual teams voting boxes. Votes will be picked up at 2:30 to be counted with winners being announced at 3PM.

**Cook and/or Team Insurance:** Cook and/or Team acknowledge that the FYP BBQ Competition does not maintain insurance covering Cook and/or Team property. If Cook and/or Team desires to insure its goods and/or equipment against theft, damage by fire, accident, or loss of any kind, it shall do so at its own expense. **Initials:** \_\_\_\_\_
